

# Candidate Report



*Sheri speaks to a crowd of hundreds about the issues in Bill C-51*

The election year is upon us. We find ourselves in a unique moment where together, we can make real and tangible changes to improve the quality of life for people in our community.

**"We deserve better,"** says Sheri. "For years, the voice of this community has been silenced at the federal level. Infrastructure and support systems have been weakened, community programs have been slashed, inequality continues to rise and the cost of living has sky-rocketed. People are working harder but it's also harder to cover the cost of living."

Sheri has been busy putting together a campaign team of staff and volunteers. They are getting

trained on new innovative canvassing technology, developing data collection plans, fundraising and communications materials, and planning how best to connect with the diversity of people in Saskatoon West.

**"It's really important to me that we engage as many people as we can in the community,"** says Sheri. "I want to reach out to people beyond our traditional supporters to include people who have felt they have been excluded, and find ways that they feel encouraged to participate and share their voices."

Sheri has been hearing from people on the doorstep that there is a real urgency to act on issues of childcare, affordable housing, and the crisis of climate change. This requires a strong and committed movement of people who will work together and push for this change.

# Why You Should Oppose Bill C-51

While terrorism is a very real threat in today's modern world, we are often faced with a false choice. Conservatives will tell us we can have freedom, or security, but not both.

Bill C-51 is an anti-terrorism bill which has raised the concerns of people and organizations across the country, notably Bill Sundhu, who served as a judge for the BC Provincial Court and Carol Baird Ellan, the first woman to be appointed Chief Judge of the BC Provincial Court.

"I couldn't just stay on the sidelines anymore. During my career as a judge, I presided over many difficult cases, and I always made sure that anyone with something to say was able to say it. This is a fundamental principle of Canadian justice, and it's under threat from Bill C-51," said Carol Baird Ellan.

When it comes to terrorism investigations, Bill C-51 overrides privacy and other legislative limits to sharing information. C-51 would give the Canadian Security Intelligence Services (CSIS) the power to disrupt potential terrorist plots and give police authority to detain suspects who "may" carry out (as opposed to "will carry" out) a terrorist act. This could extend to striking unions, Aboriginal and environmental activist groups, anti-war demonstrations, etc. Bill C-51 defines anyone who poses a threat to the economy, the political and the diplomatic agenda of the government, as a terrorist. It excludes what it calls "lawful advocacy, protest, dissent and artistic expression". The issue at hand is that the bill does not provide a means to test what is "lawful" and what is not.

Conservative MP Diane Ablonczy displayed the government's contempt of anyone with concerns about this bill on the final day of its hearings. She uses "air quotes" (quotation marks gestured by a speaker's fingers in the air, to indicate that what is being said is ironic or mocking) and dismissed amendments to the legislation which would prevent Canadian judges from authorizing violations of the Charter.

The NDP has introduced a number of amendments to try and balance this legislation. Amendments include: deleting provisions that undermine Canadians' rights and freedoms; adding effective provisions missing from C-51 such as strengthening existing oversight of security and intelligence agencies; and limiting the scope of the Bill by protecting privacy rights and narrowing the information sharing provision to cover only terrorism.

This Bill is dangerous and we must oppose this threat on our freedom and liberties.
